- A highly successful launch to our CDC aligned diabetes prevention/lifestyle change program.
- A "superstar" award from Mental Health America for our mental health first aid program.
- A pilot program to distribute Narcan and fentanyl test strips to non profits in our community to help combat the opioid crisis.
- Supporting North County Fire Protection District's ongoing mission through our JPA and in helping to purchase new ambulances and equipment as well as to support their ongoing training through their medical services officer.
- Programming at the Community Health & Wellness Center that supports mental health, physical fitness, mindfulness, physical health, screenings, vaccinations, blood drives, and ongoing health education.
- Supporting vital community services through our Community Health Contract Grants program and partners such as: Fallbrook Food Pantry, Boys & Girls Club, Foundation for Senior Care, Palomar Family Counseling Service, Michelle's Place, and REINS.

Power of Your Penny

The Fallbrook Regional Health District has served the evolving health and wellness needs of the community since 1950. As a local special district, we are a single function, non-enterprise, independent government agency serving a defined geographic area. Simply stated, we are a local agency organized to provide public service to the local community. We are an autonomous government entity accountable to the voters of Bonsall, De Luz, Fallbrook and Rainbow. As a special district we must follow the state laws pertaining to public meetings, bonded debt, record keeping and elections. Our five-member Board of Directors are elected by the community using a zone-based process, while the staff works to implement the Board's vision and strategic direction. We receive our funding from property taxes and investments.




For every \$1 in property taxes collected by San Diego County FRHD receives .00038 (less than a penny)

Funding the Friendly Village

Fallbrook Regional Health District received \$2,333,423 in revenue during the 2022-2023 fiscal year. The chart opposite illustrates how money was apportioned to support the health and wellbeing of the community. The total operating expenses were \$2,091,754. The District approved \$806,129 in Community Health Contracts; which are grants made to community nonprofits and care service providers. District Direct Care Services are services we provide via our staff and or sponsor directly.

Health & Wellness Priorities

Building upon the results from our 2020 Community Needs Assessment, we have continued to follow a Social Determinants of Health paradigm to guide our efforts in how we fund and select service offerings that can make the deepest impact on the community. The Social Determinants of Health are defined as the conditions in the environments where people are born, live, learn, work, play, worship, and age that affect a wide range of health, functioning, and quality-of-life outcomes and risks.

The Community Needs Assessments identified several areas of unmet need, the District focused its resources toward supporting those areas. While we will continue supporting our nonprofit health and wellness partners, it is our goal to bring additional services to the community.

Facility Updates

The renovation of the Community Health & Wellness Center has taken a different process. The initial plans for remodeling came in with a cost that the Board was uncomfortable with approving. Instead, the Board chose to break the remodeling into smaller, more manageable projects that aligned with our specific programming goals. We anticipate that several of these projects will continue through 2025.

Building B-Education Center

Repainted the exterior, retrofitted the windows, and created seating around the exterior of the building. Interior classrooms were updated with new paint, lighting, flooring, and technology. A Welcome Center and Staff offices were created to streamline our ability to provide services and increase communication.

The District is researching a project that would allow us to install solar shade structures, install EV chargers and replace our old parking lot. Our goal is to make


the Center a self-contained site where we could serve as a cooling center, emergency services triage location, and a community resource center during times of need.
